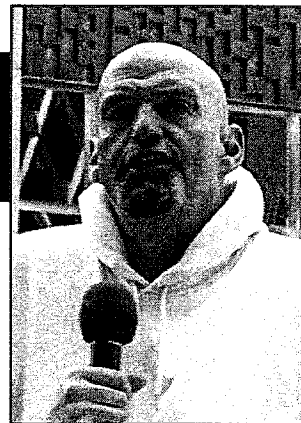

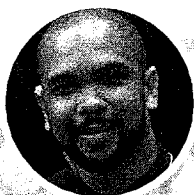
## FOR U.S. SENATE
